Meeting Notes

Tuesday 31 July 2018, 2.30 – 3.30pm Waikato Regional Council, RIG Room

Objective

The purpose of the meeting is to discuss Stats NZ's recently announced delays with the release of 2018 Census data and products, including the implications this may have on the Waikato projections work.

2018 Census – delays with release of data

End July 2018 Statistics NZ has released a statement that as a result of the much lower than expected fill-in rate (90%, compared to 94.5% in 2013) more work will be needed to fill-in the data gaps. This will result in some delays in releasing Census data< see:

WRC has invited Stats NZ to attend today's meeting, their response is included in Appendix 1.

While Stats NZ notes that the quality of the data will not be compromised, they indicate that more time is required. Myk Cameron (University of Waikato) confirmed that data quality will not be an issue for most products. However, the release of data, especially household data and data for small areas (including SA2), is likely to be delayed for up to six months.

Our current timeline (see diagram next page) was planned to make the projection data available <u>by Feb 2020</u> in time for preparing the LTP 2021-2031. This will now have to be revised, from a 'best case' scenario of <u>April 2020 to a 'worst case' scenario of August/September 2020</u>. With the exception of the first release of census data, now postponed from October 2018 to March 2019, no other release dates have been confirmed. Note that the household data, critical for the Waikato projection work, is usually amongst the last data releases.

Our target delivery date of all projections data (February 2020) may not be able to be met. If that is the case, it was suggested to use the current projections based on the 2013 Census, at least in the initial LTP 2012-2031 process. Councils agreed with this approach, and supported to go ahead with the timeline as per the diagram below, noticing some uncertainty in the delivery data.

Waikato Projections – timeline and deliverables

The diagram below summarises the tasks and timeline agreed by the Projection Working Group at our last meeting in March 2018, indicating potential delays in the release of Stats NZ data.

The deliverables were confirmed, with one change: It was requested that the projections for the TA level data should be undertaken at yearly time steps. Myk agreed to include this at no extra cost.


Confirmed projections data to be delivered by February 2020 (subject to delays of Stats NZ data releases):

- **By Territorial Authority Boundary** (yearly time steps):
 - Land Use (by WISE land use class)
 - Population (by gender/age cohorts)
 - Households (by household type)
 - o Labour force
 - o Employment (as Modified Employee Counts, MEC's)
 - Value Added (\$m)
- By SA2 (new Census Area Units) boundary (time steps 2018, 2025, 2035, 2045, 2055, 2065):
 - Land Use (by WISE land use class)
 - Population (total)
 - Households (total)
 - o Labour force
 - Employment (as MEC's)
 - Value Added (\$m)

Separate reports will be produced for TA and Small Area (SA2) projections, summarising data regionally and by district. Councils agreed that the (initial) projections will be based on a medium scenario. HCC expressed the possibility of subsequently undertaking low (or high) projections, depending on the results of the medium projections. Additional costs for low/high (\$12k) is not included in the contract and would have to be covered by the TA(s) requiring other than medium projections.

Data by settlement/urban areas for these projected parameters could be derived by simple summation of appropriate SA2 units. For further details (e.g. deriving projections for dwellings, rating units) refer to the 'Issues and Options' paper on the website.

WRC is progressing the detailed specification and contracting of the various work streams required to update the population, economic and land use/zoning data and projections based on the 2018 Census. The final work brief with the specs for the contract are available from the <u>website</u>.
